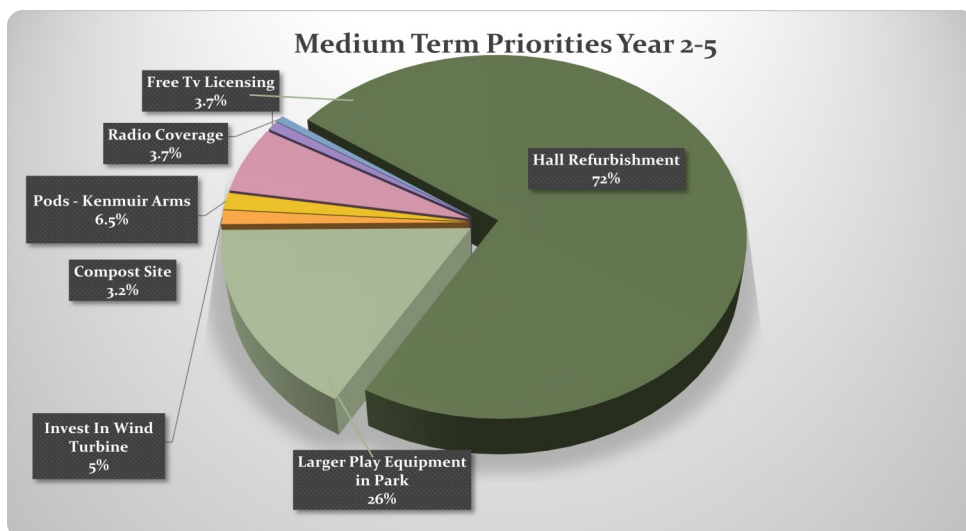
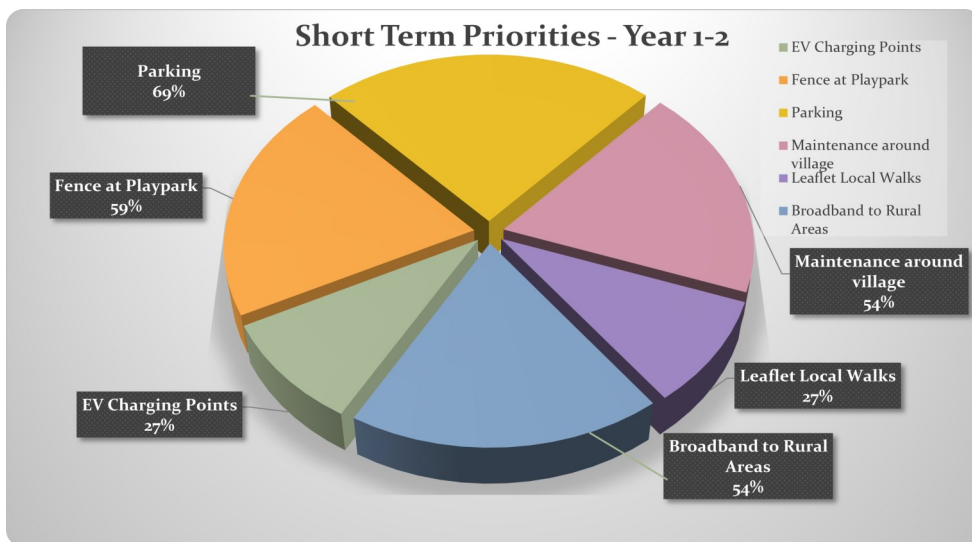
# Community Action Plan
